Let it glow! The 32nd annual **Festival of Trees – A Celebration of Giving** was a vibrant kick off to the holiday season.

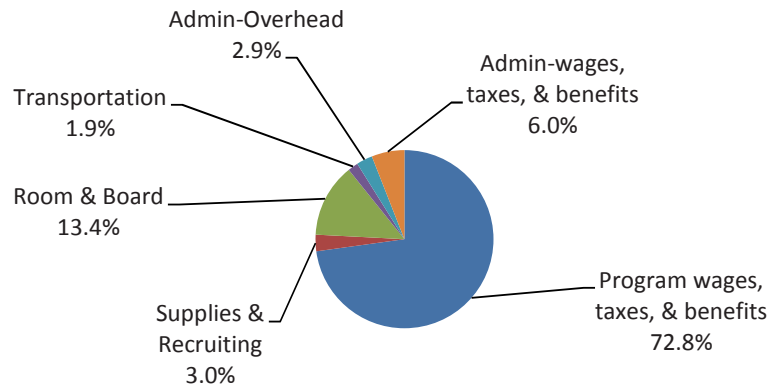
- **109** dazzling trees filled the Exhibit Hall.
