Emergency Preparedness

Also known as our rainy day reserve, the Emergency Preparedness Fund is a designated gift area available to respond to an unexpected situation. It's safe to say that the COVID-19 pandemic was just that. Fortunately, we had funds available to jump into action before getting into the thick of things. Agency-wide, the expenses for personal protective equipment (PPE) exceeded \$50,000. The Foundation supported the purchases with almost \$23,000 in funding from our EP Fund to purchase masks, gloves, eye protection, disinfectant, wireless adapters, and web cameras.









The goal was making a connection, and thanks to her hard work, and the hard work of the HH team, we were able to be "together" while remaining at least 6 feet apart.


In 2020, we celebrated 35 years of the Festival of Trees alongside an international pandemic. As the world adjusted to a new normal, the HHF team, along with the FOT Committee, shifted gears and developed a pandemic-approved Festival. We showcased 81 trees in 29 locations around the community, hosted a hybrid Opening Night Gala, provided take-home craft and cookie kits, and showcased virtual ability awareness lessons. 


